## **REQUEST FOR TECHNICAL CHANGE**

The Rules Review Commission staff has completed its review of this rule prior to the Commission's next meeting. The Commission has not yet reviewed this rule and therefore there has not been a determination as to whether the rule will be approved. You may call this office to inquire concerning the staff recommendation.

In reviewing these rules, the staff determined that the following technical changes need to be made:

In this Rule, please show all changes made to original text currently in the NCAC. For example, on line 6, the language currently reads:

## 19A NCAC 03B .0201 DRIVER'S LICENSE EXAMINATION

(a) The Division shall issue a driver's license to any person who passes the driver license examination and is otherwise eligible to hold a license. Applicants for a driver's license are subject to the following tests:

In your language, you have "moved" the colon following "tests" in the second sentence and cannot do that. You must show the changes, thusly:

Applicants for a driver's license are subject to the following tests: tests and requirements:

In (a)(2), line 13, what is meant by "regular"? Is this as opposed to restricted?

In (a)(3), line 16, why is "applicant" capitalized?

Also on line 17, I recommend stating, "A license" or The license shall be restricted ... "

In (a)(4), line 22, this is not the proper way to insert a comma, as punctuation is treated as part of the word that preceded it. (Note the same for line 27)

On line 22, do individuals know what is meant by "attention"? I am assuming "attention to driving, the road, etc." is this correct? And what is "controls"?

In (a)(5), line 26, replace "will" with "shall" or state "The Division of Motor Vehicles shall post instructions for applicants for remote renewal of its website at ..."

I recommend giving the full citation in (a)(5) to "G.S. 20-7(f)(6)c."

In (a)(6), line 29, generally the term "shall" is preferred over "must" in rules. Is the "must" applicable to the individual or the agency here?

In (a)(6), the (i) through (v) was changed to (A) through (E) for publication. As that is correct formatting, please change it back.

Please have (a)(6)(i) through (v) begin with lowercase letters, as they are a list.

In current (a)(6)(i), line 31, should it read "address listed or shown on..."?

In current (a)(6)(iii), this is not the correct way to change the word from "provide" to "provided" Please follow Rule 26 NCAC 02C .0405(b)(2). Please note the same change for Page 2, line 25, changing "Applicants" to "applicants"

In (a)(6)(iv), what is "successful"? Do you mean that they passed per the standards in (a)(3)?

In (a)(7), Page 2, line 2, please insert a comma after "renewal"

In (a)(8), please insert a comma after "process" on line 4.

On line 5, should it read, "The <u>applicant</u> may use..." or "The <u>individual</u> may use the current license..."?

The language in (b)(2), line 16 contradicts the language in (a)(6)(iv). Should there have been no change in the last 6 months or no change since the last exam? And who makes the determination that it will impair the driver's ability – the driver?

I suggest saying at the end of (b)(1), (3), (4) and (5), "Applicants in this Subparagraph are not eligible to apply for remote renewal."

In the History Note, not all of 20-7(a) through (f) is applicable to this Rule, is it? It appears that (a), (c), (e) and (f) are applicable here. Please give the citations you are relying upon for authority for this Rule.

1 19A NCAC 03B.0201 is amended as published in 29:12 NCR 1486 as follows: 2 3 19A NCAC 03B .0201 DRIVER'S LICENSE EXAMINATION AND ONLINE RENEWAL 4 (a) The Division shall issue a driver's license to any person who passes the tests and meets the requirements listed 5 below the driver license examination and is otherwise eligible under G.S. 20 to hold a license. Applicants for a 6 driver's license are subject to the following tests and requirements: 7 Knowledge Examination. This is an automated computer test on knowledge of rules of the road. (1)8 An audio component allows <del>customers</del> <u>applicants</u> with reading comprehension difficulties to listen 9 to the test questions by use of earphones. Eighty percent of the questions shall be answered 10 correctly in order to pass the knowledge examination. For the issuance of a remote renewal, the 11 requirement of a knowledge examination shall be waived. 12 (2)Road Signs. This is a test on knowledge of highway signs and their meanings. Applicants for a 13 regular Class "C" license shall correctly identify nine of twelve road signs. Applicants for "A" or 14 "B" licenses shall correctly identify all road signs. For the issuance of a remote renewal, the 15 requirement of the road signs test shall be waived. 16 (3) Visual Acuity Test. Applicant's The Applicant's visual acuity shall be 20/40 or better in either eye 17 or both eyes together to receive an unrestricted license. License is restricted to require corrective 18 lenses if acuity is less than 20/40 in either eye or both eyes together. 19 (4) Road Test. The road test measures the applicant's ability to operate a motor vehicle safely in 20 actual traffic situations. The required maneuvers are: quick stop, turnabout, backing, approach 21 corner, right turns, left turns, traffic lights, use of controls, starts, use of lanes, use of brakes, 22 following following, and attention. Approval or disapproval is determined by the driver license 23 examiner based upon the applicant's ability to execute the required maneuvers. For the issuance 24 of a remote renewal, the requirement of a road test shall be waived. 25 (5) Remote Renewal. The renewal of a driver's license by mail, telephone, or electronic device. 26 Applicants will find instructions for remote renewal on the Division of Motor Vehicles' Website 27 at http://www.ncdot.gov/dmv. A driver's license issued by remote renewal expires in accordance 28 with G.S. 20-7(f)(6). 29 Attestation. An applicant eligible to make application for a remote renewal must truthfully attest (6) 30 to the following as part of the application for a remote renewal: 31 (i) The applicant is a resident of North Carolina and currently resides at the address on the 32 license to be renewed; 33 (ii) The license holder's name as it appears on the license to be renewed has not changed; 34 (iii) All information provided during the application for a remote renewal has been provided 35 truthfully; 36 (iv) That no change in vision has occurred since the last successful visual acuity test 37 examination completed by DMV to safely operate a motor vehicle; and 38

(v) That no change in physical or mental abilities has occurred since the last issuance.
