

REQUEST FOR TECHNICAL CHANGE

AGENCY: Board of Refrigeration Examiners

*In the Rule, please insert a complete introductory statement at the top of the page, as required by 26 NCAC 02C .0404. I suggest, "21 NCAC 60 .0102 is amended without notice or hearing pursuant to G.S. 150B-21.5(a)(4) as follows:"*

*When formatting, please use 1.5 line spacing and insert line numbers. (See Rule 26 NCAC 02C .0108.)*

*Do not indent Paragraphs (a), (b), or (c).*

*Is there a reason you do not want to combine (a) and (b)? Do you anticipate that the mailing or physical address might change and you'd only want to change one Paragraph? If they cannot be combined, why is the zip code only Paragraph (b)?*

*Are the Board's rules and materials used in rulemaking available on the website? If so, perhaps you could say that in the Rule?*

*In the History Note, please strike through G.S. 150B-11(2), as that law has been repealed.*

*Also in the History Note, please underline June 1, 2015. Also, the effective date is entirely up to the agency, but the Rule could be effective as soon as April 1, 2015. Do you want to set that as the effective date, instead of June?*
