3 **10A NCAC 46 .0201 MANDATED SERVICES**

4 The following is a list of mandated services required to be provided in every county of this state. The local health department
5 shall provide or ensure the provision of these services:

- 6 (1) Adult Health;
- 7 (2) Home Health;
- 8 (3) Dental Public Health;
- 9 (4) Food, Lodging and Institutional Sanitation;
- 10 (5) Individual On-Site Water Supply;
- 11 (6) Sanitary Sewage Collection, Treatment and Disposal;
- 12 ~~(7) Grade A Milk Sanitation;~~
- 13 ~~(7)(8)~~ Communicable Disease Control;
- 14 ~~(8)(9)~~ Vital Records Registration;
- 15 ~~(9)(10)~~ Maternal Health;
- 16 ~~(10)(11)~~ Child Health;
- 17 ~~(11)(12)~~ Family Planning;
- 18 ~~(12)(13)~~ Public Health Laboratory Support.
