Most counties elect to transfer highly contagious inmates, such as those who have TB, to another facility that is more properly equipped and better trained to handle such a patient. Only very large facilities such as Charlotte may have the doctors, nurses, facilities, and other resources needed to house contagious inmates. Jails may have a detainee come in that is either unaware that they are infected or may conceal the fact that they are infected from staff. For most counties a jail will only have a very limited interaction with an infected detainee before transferring them out. Jails will not have all the elaborate filtration systems, controls, and isolation areas that a hospital can have. Jail architects and engineers can use some simple specific guidelines to address medical isolation / prevention as a first line of defense. Something that states for example a number of air changes per hour and cfm/pressure differential guidelines that can be used based off of CDC recommendations. Discharging 100% of the medical area / medical isolation cells air directly to the outside 100% of the time on the off-chance an inmate would conceal his infection would be a heavy utility cost burden. I would suggest the mechanical systems be isolated so air from these areas can't be recirculated to other areas of the facility. If a separate exercise area is not provided and the dormitory serves as the exercise area to fulfill the requirements of 10A NCAC 14J .1004 the minimum floor space shall be 500 square feet (exclusive of lavatories, showers, and toilets) or 70 square feet per inmate (exclusive of lavatories, showers, and toilets) plus 200 square feet, whichever is greater. ACA also requires a minimum ceiling height of 18 feet for interior exercise area? Would that be an undue burden on smaller facilities? Perhaps make the ceiling height 10 feet or 12 feet minimum?
