

Explain: The Certificate of Need (CON) application forms authorized by G.S. 131E-182(b) request information from the applicants which is designed to address the review criteria found in G.S. 131E-183(a). The rules to be repealed are not needed to determine whether or not an application is conforming to the statutory review criteria. Furthermore, some of the rules to be repealed are vague and many are outdated. Standards and practices in the health care industry that were appropriate in the 1980's and 90's are not the best, most current practices. The rules to be repealed also place an unnecessary burden on CON applicants and increase the complexity of litigation which has a cost to both the Department and CON applicants.
