Dear Mr. Dunklin:

I am writing to you pursuant to 26 NCAC 05 .0204 to request an extension of time within which to file the Periodic Review of Existing Review Report for the submission to the Rules Review Commission for the Division of Social Services (DSS). The DSS is hereby requesting an extension of time from the Commission in reference to the following:

- i. 26 NCAC 05-0204 item (a) (3) changes of composition to the agency or its staff that resulted in a delay of the review; and
- ii. Session Law 2015-241, Section 12C.9 requires the Department to establish a State Foster Care Benefits Program with appropriations by the General Assembly for the purpose of providing assistance to children who are placed in foster care facilities by county departments of social services in accordance with the rules and regulations of the Social Services Commission. The required implementation date is January 1, 2017.

The DSS is experiencing a high number of vacancies particularly in the management and administrative support positions in the Child Welfare Regulatory and Licensing Services Section. These positions are responsible for conducting the periodic rules review process. The Department would be better served to implement new rules for Fostering Success/Extend Foster Care to 21 Years of Age prior to the periodic rules review process beginning in January 2016. The Department requests an extension for review to begin in January 2017, after the implementation of the new rules for foster care.

The DSS is presently hiring for the vacant positions to increase resources to address the delay of reports and avoid future delays. Currently, staff are reviewing 10A NCAC 70A-H to meet legislative deadlines regarding foster care.

The Division of Social Services regrets any inconvenience that the delay may cause and sincerely appreciates your time and consideration.
