3 **10A NCAC 45A .0101 GENERAL**

4 (a) The purpose of this Subchapter is to establish uniform policies and procedures for the administration of all  
5 Department of Health and Human Services' payment programs for which the Commission for Public Health has  
6 been granted rulemaking authority.

7 (b) In the event of conflict between the rules in this Subchapter and the rules adopted by the various payment  
8 programs, the rules of this Subchapter will control.
