# RULES REVIEW COMMISSION MEETING MINUTES May 19, 2016

#### **Public Safety – Division of Emergency Management**

14B NCAC 03 .0101, .0102, .0103, and .0202 were withdrawn at the request of the agency.

The Commission objected to 14B NCAC 03 .0104 in accordance with G.S. 150B-21.10. The Commission objected to the rule, finding the agency failed to comply with the Administrative Procedure Act. Specifically, the Commission found that the text presented was not a rule as defined in G.S. 150B-2(8a), as the contents set forth only the internal management of the agency and does not affect the procedural or substantive rights of anyone outside of the agency.

#### **Public Safety - State Capitol Police**

The Commission voted to extend the period of review for 14B NCAC .0102, .0201, .0202, and .0203 in accordance with G.S. 150B-21.10 with Commissioner Doran voting against. They did so in response to a request from the Public Safety - State Capitol Police to allow additional time for review of technical change requests.
