Please revise the "Submission for Permanent Rule" form, correcting the Notice of Text publication date, which should be 4/1/2016 rather than 3/9/2016.

Line 1 – underline "with changes"

Line 9 – add "at" or "on" before "the following"

Line 11 – replace "may" with "shall not" and replace "a maximum of" with "more than"

Lines 12-15 – remove the underlining under the text that was proposed to be added and now is to be deleted.

Line 16 – replace "by" with "no later than"

Line 19 – replace "are due by" with "shall be received by the Department no later than"

Line 25 – consider adding "143B-135.200" to your Authority.

3 **15A NCAC 12K .0103 FUNDING CYCLE**

4 Annual funding schedule dates shall be the following:

5 (1) An announcement letter describing the funding schedule and how to apply shall be mailed to all
6 eligible applicants by ~~September 30~~ November 1. This information shall be made available to other
7 interested parties who contact the Department of ~~Environment and Natural Resources~~ Natural and
8 Cultural Resources (Department) at: NC Division of Parks and Recreation, ~~PO Box 27687 1615~~
9 MSC, Raleigh, North Carolina 27611-7687 27699-1615 as well as the following website:

11 (2) Local governments may request a maximum of five hundred thousand dollars (\$500,000) in PARTF
12 assistance with each application. ~~[The Parks and Recreation Authority may reduce the maximum~~
13 ~~grant amount by up to \$250,000 if total amount of grant funds available are below \$5 million for~~
14 ~~the fiscal year. Changes to the maximum grant amount will be included in the announcement letter~~
15 ~~for the current grant cycle pursuant to Item (1) of this Rule.]~~

16 (3) Applications shall be received by the Department or its designee by 5:00 p.m. ~~on January 31 of the~~
17 ~~deadline date stated in the announcement letter for the current grant cycle pursuant to Item (1) of~~
18 ~~this Rule. The Parks and Recreation Authority will set the deadline date for between January 31~~
19 ~~and May 30. If the deadline falls on a weekend or holiday, applications are due by 5:00 p.m. on the~~
20 ~~following business day.~~

21 (4) The Authority shall meet within ~~420~~ 180 days of the application deadline to select projects for
22 funding. ~~The Authority shall meet within 30 days after the end of the fiscal year to select projects~~
23 ~~for funding using revenues credited to PARTF during the fourth quarter.~~
