Two of the rules to be repealed, 10A NCAC 14C .3201 and .3203, are inconsistent with the State Medical Facilities Plan and are not needed in order for the agency to determine whether or not an application is conforming to the statutory review criteria. Furthermore, four of the rules to be repealed are unnecessary or outdated, 10A NCAC 14C .0103, .0201, .0401 and .0403. The rules to be repealed also place an unnecessary burden on applicants and increase the complexity of litigation which has a cost to the Department and the applicants.



Explain: For the Zika Virus Infection, it is imperative that public health authorities be rapidly notified when this infection is suspected so that appropriate education can be provided and control measures can be implemented to mitigate the risk of local transmission. For the Hepatitis C virus (HCV) infection, approximately 75-85 percent of infected individuals develop chronic disease. Although highly effective treatments are now available, most individuals with chronic HCV infection are unaware of their infection and thus do not receive the recommended care and treatment. This amendment will provide NC public health authorities with the data needed to estimate the burden of chronic HCV infection in NC and more precisely direct public health activities and resources that address chronic HCV infection..
