3 SECTION .0105 - APPLICABILITY OF BOARD RULES

5 ~~The Executive Director shall mail a copy of Article 11 of Chapter 90 of the North Carolina General Statutes and~~  
6 ~~the rules of the Board adopted under Chapter 90 to all applicants applying for licensure. Additional copies are~~  
7 ~~available from the Executive Director at the Board office.~~ Rules adopted and published by the Board under the  
8 provisions of Article 11 of Chapter 90 and G.S. 150B shall be binding upon every individual holding a license  
9 from the Board, and upon all professional corporations and entities legally authorized to offer or to perform  
10 veterinary services in this state. All licensees of the Board are charged with having knowledge of the existence  
11 of the Board rules and shall be deemed to be familiar with their several provisions and to understand them.
