*If you don't wish to do this, delete "currently" on line 5, as it repeats "current" on that same line and on line 6.*

*Also on line 5, what do you mean by "proper"*

*On line 7, who is making the report here? Each licensee or registrant?*

*On line 8, replace "must" with "shall"*

*On line 9, I believe "photocopies" is one word.*

*On line 10, what if the individual can't get a card within 60 days?*

3 **SECTION .0106 -CURRENT INFORMATION REQUIRED BY THE BOARD**

5 Each licensee and registrant shall keep the Board currently advised as to his or her proper and current mailing address and the  
6 name, address, and phone number of the current place of employment within 60 days of any change. All changes of  
7 professional association, or dissolution of a professional relationship, shall be reported within 60 days to the Executive  
8 Director together with the new status and addresses of the individuals or firm. All changes in legal name must be reported  
9 within 60 days, in writing, to the Board office accompanied by photo copies of the licensee's or registrant's legal  
10 documentation creating the change and a social security card showing the new legal name.
