24 (p) Shooting Ranges. On public shooting ranges managed by the Commission, no person shall use designated 25 shooting ranges for any purpose other than for firearm or bow and arrow marksmanship, development of shooting 26 skills, or for other safe uses of firearms and archery equipment. All other uses, including camping, building fires, 27 operating concessions or other activities not directly involved with recreational or competitive shooting are prohibited, 28 except for activities that have been approved by the Commission and for which a permit has been issued may be 29 conducted, provided that the permit authorizing such activity is available for inspection by wildlife enforcement 30 officers at the time the activity is taking place. No person, when using any shooting range, shall deposit any debris or 31 refuse on the grounds of the range. No person may leave any vehicle or other obstruction in such a location or position that it 34 will prevent, impede, or inconvenience the use by other persons of any shooting range. No person shall leave parked 35 any vehicle or other object at any place on the shooting range other than such a place or zone as is designated as an 36 authorized parking zone and posted or marked as such. No person shall handle any firearms or bow and arrow on a 37 shooting range in a careless or reckless manner. No person shall intentionally shoot into any target holder, post, or

1 other permanent fixture or structure while using a shooting range. No person shall shoot a firearm in a manner that 2 would cause any rifled or smoothbore projectiles to travel off of the range, except that shotgun shot, size No. 4 or 3 smaller may be allowed to travel from the range if it presents no risk of harm or injury to any person(s). Persons using 4 a shooting range shall obey posted range safety rules and those persons who violate range safety rules or create a 5 public safety hazard shall leave the shooting range if directed to by law enforcement officers or to leave by 6 Commission employees. No person shall handle any firearms on a shooting range while under the influence of an 7 impairing substance. The consumption of alcohol or alcoholic beverages on a shooting range is prohibited. Open 8 days and hours of operation shall be designated on signs and at least one of such signs will sign shall be posted at the 9 entrance to each shooting range. No person, when using any shooting range, shall do any act that is prohibited or 10 neglect to do any act that is required by signs or markings placed on such area under authority of this Rule for the 11 purpose of regulating the use of the area. 12 (q) Limited-access Roads. During the months of June, July, and August, roads posted as "Limited-access Roads" are 13 open to motorized vehicles from 5:00 a.m. to 10:00 p.m. only. - 8 or otherwise prevent vehicles from using any roadway.
- 9 (c) Tree Stands. It is unlawful to erect or to occupy, for the purpose of hunting, any tree stand or platform attached
- 10 by nails, screws, bolts, or wire to a tree on any game land designated herein. This prohibition does not apply to lag-
- 11 screw steps or portable stands that are removed after use with no metal remaining in or attached to the tree.

12 (d) Time and Manner of Taking. Hunting is allowed on game lands only during the open season for game animals

13 and game birds, unless hunting is allowed by permit. Individual game lands or parts thereof may be closed to hunting

14 or limited to specific dates by this Chapter. Persons shall hunt only with weapons lawful for the open game animal or

- 15 game bird seasons. On managed waterfowl impoundments, persons shall:
- 16
- not enter the posted impoundment areas earlier than 4:00 a.m. on the permitted hunting dates; (1)
- 17 (2)not hunt after 1:00 p.m. on such hunting dates;
- 18 (3) not set decoys out prior to 4:00 a.m.;
- 19 (4) remove decoys by 3:00 p.m. each day; and

20 (5) not operate any vessel or vehicle powered by an internal combustion engine.

21 On designated youth waterfowl days occurring after the end of the regular waterfowl seasons only, youths may hunt 22 on managed waterfowl impoundments from $\frac{1}{2}$ hour before sunrise to sunset. Restrictions (1), (3), and (5) in this 23 Paragraph shall apply. On waterfowl impoundments that have a posted "Scouting-only Zone," trapping during the 24 trapping season and waterfowl hunting on designated waterfowl hunting days are the only activities allowed on the 25 portion of the impoundment outside of the posted "Scouting-only Zone." No person shall attempt to obscure the sex 26 or age of any bird or animal taken by severing the head or any other part thereof, or possess any bird or animal that 27 has been so mutilated. No person shall place, or cause to be placed on any game land, salt, grain, fruit, or other foods 28 without prior written authorization of the Commission or its agent. A decision to grant or deny authorization shall be 29 made based on the best management practices for the wildlife species in question. No person shall take or attempt to 30 take any game birds or game animals attracted to such foods.
