Dear Chairman Dunklin:

I am writing to you pursuant to 26 NCAC 05 .0204(a) to request an extension of time within which to file the Periodic Review and Expiration of Existing Rules Report for Submission to the Rules Review Commission for the rules contained in Title 21, Chapter 54 of the N.C. Administrative Code, entitled North Carolina Psychology Board.

The Board only meets four times a year and it began the process of reviewing its existing rules for purposes of this review at a Board meeting last year. However, Board staff was not able to complete the process within the requisite deadlines due to the loss of the Board investigator, who is a critical member of the Board staff. As a result of this staffing shortage, the Executive Director was responsible for performing both his job and many of the responsibilities of the Board investigator during the interim until a new investigator was hired.

The new investigator has been hired and trained so that the Executive Director can now focus on his primary job responsibilities. The North Carolina Psychology Board appreciates that the periodic review of existing rules is an important and necessary process and I have asked Board staff to make this a priority.


