Line 8, the agency appears to be deleting a late renewal fee not captured by another rule. Please just verify if that is correct.

Line 17, replace "law." with "G.S. 25-3-506."

Line 19, should the "must" be a "may"? Please review and consider clarifying

Line 20, add a comma after "credit card"

Line 22, consider deleting "25-3-506" as that would be cited on line 17

Line 22, consider adding "90-270.26" as statutory authority for this Rule

3 **21 NCAC 48F .0102 FEES**

4 (a) The following fees are charged by the Board:

- 5 (1) application for physical therapist licensure, one hundred fifty dollars (\$150.00);
- 6 (2) application for physical therapist assistant licensure, one hundred fifty dollars (\$150.00);
- 7 (3) renewal for all persons, one hundred twenty dollars ~~(\$100.00); (\$120.00);~~
- 8 ~~(4) penalty for late renewal, twenty dollars (\$20.00) plus renewal fee;~~
- 9 ~~(5)(4)~~ revival of license lapsed less than five years, thirty dollars (\$30.00) plus renewal fee;
- 10 ~~(6)(5)~~ transfer of licensure information fee, including either the examination scores or licensure verification
11 or both, thirty dollars (\$30.00);
- 12 ~~(7)(6)~~ retake examination, sixty dollars (\$60.00);
- 13 ~~(8)(7)~~ certificate replacement or duplicate, thirty dollars (\$30.00);
- 14 ~~(9) directory of licensees, ten dollars (\$10.00);~~
- 15 ~~(10)(8)~~ licensee list or labels or any portion thereof for physical therapists, sixty dollars (\$60.00);
- 16 ~~(11)(9)~~ licensee list or labels or any portion thereof for physical therapist assistants, sixty dollars (\$60.00); and
- 17 ~~(12)(10)~~ processing fee for returned checks, maximum allowed by law.

18 (b) The application fee is not refundable.

19 (c) Payment of application fees listed in Subparagraphs (a)(1) and (2) of this Rule must be made by certified check, cash,
20 credit card or debit card.
