> Re: Periodic Review and Expiration of Existing Rules Title 10A, Subchapter 70D – Payment of Grants-in-aid to Private Child-Caring Institutions

Dear Chairman Pledger:

At today's meeting the Rules Review Commission (RRC) considered and approved several existing rules reports submitted by the N.C. Social Services Commission (SSC). However, the SSC did not file a report for rules codified in 10A NCAC 70D.

Pursuant to G.S. 150B-21.3A, all agencies subject to rulemaking under Article 2A of the North Carolina Administrative Procedure Act are required to review all existing rules in the North Carolina Administrative Code. The RRC is required to set the schedule for each agency to conduct this review. That schedule was adopted by the RRC effective April 1, 2014, and is set forth in Rule 26 NCAC 05 .0211.

Because the SSC did not file the report for Subchapter 70D within the allotted time, the rules expire today, August 17, 2017, pursuant to G.S. 150B-21.3A(b). The Codifier of Rules will remove the rules from the North Carolina Administrative Code.
