Hi Cathe,

Thanks for sending these over. While reviewing I found a few minor typos/errors (i.e. in .0206 there was an apostrophe instead of a quotation mark after “easy editing”) that I corrected. I am comfortable with recommending approval of all but two at this time, but I think we’re close on those two.

Rule .0203

I looked back at the prior versions of the rules that you’ve brought together here, and the “health, safety, and welfare” language we’ve been discussing seems to come from the old R. 0203, which stated that “...the architect shall conduct his office and all aspects of his practice in such manner as to “safeguard life, health and property” as provided in G.S. 83A-12.” (I note the oxford comma is lacking, but that’s in the statute). Would restoring this language, or otherwise tying what you have to 83A-12 retain the Board’s intent? I think that would get me over the hump, so to speak.

Rule .0905

I’m still a little unclear on what is being required in (a). The language that I was asking about wasn’t “required,” but “include,” because it seems that you’re listing these 3 kinds of records that the registrant shall maintain, but suggesting with “include” that there are other records that could satisfy the requirement but aren’t listed. Are there other ways to satisfy the records requirement, or are the three means listed here it?

Also, I noticed that the formatting is off in R. 0206, as some of the tabs are incorrect, but these will be corrected when the Rule goes into our template before being inserted into the Code. Just wanted you to be aware.
