




We have seen in the past the many times when unlicensed entities such as Estate Tag companies start an auction between clients for the sale of goods, and venues that promote their site as an auction company or use live electronic bidding as a method to increase the values. Because of those issues, I encourage a change in the rules to say:

My suggestion is that this change to state "It is the responsibility of the Board to:

License Auctioneers
License Apprentice Auctioneers
License Auction Firms

and to investigate complaints of individuals and firms that are acting as auctioneers and take appropriate action in regards the law and their responsibility for licensing those entities, and ensure that the qualifications and activities of those engaged in auctioneering activities are in accord with the law and in the best interest of the public."

Then keeping "The Board id not a board of arbitration." However, I do believe that there needs to be a board of arbitration or other entity that will resolve those complaints - if it is auctioneering - then I believe it is the Board, if it is fraud as I have heard reported several times - then I believe the recommendation to the sate should be to

license Tag Companies. Just my opinion.
