Mr. Harris,

Good morning, and thank you for your e-mail. Admittedly, I am a bit confused by your question, but I hope you will find the below information helpful and responsive.

The Board was previously scheduled to have its G.S. 150B-21.3A report reviewed by the Rules Review Commission in June 2018, pursuant to the original schedule codified at 26 NCAC 05 .0211. However, the Board voted at its February 8, 2017 meeting to request from the RRC a waiver of 26 NCAC 05 .0211 in favor of having the Board's G.S. 150B-21.3A report reviewed by the RRC at an earlier time. The Board's request for a waiver was unanimously approved by the RRC at its February 16, 2017 Board meeting. Accordingly, the RRC rescheduled the date of review for the Board's G.S. 150B-21.3A report to the Rules Review Commission meeting scheduled for June 15, 2017.

Also at its February meeting, the Board voted to approve initial classifications of its rules – attached please find a copy of the Board's initial report for your convenience. Following the Board's vote on February 8, 2017, Board staff posted a link to the report on the NCBFS website and disseminated the report to the Board's e-mail distribution list. The report was also posted on the RRC's website. The Board held a public comment period on the its initial rule classifications from February 8, 2017 through April 21, 2017. Now that the public comment period has expired, the next step in the periodic review process is for the Board to vote on final rule classifications at its meeting next Wednesday, May 10. Board staff will then submit the Board's final report to the Rules Review Commission for review at the RRC's June 15, 2017 meeting.
