

The operating room need methodology was changed in the 2018 SMFP that was signed by the governor on December 11, 2017 and became effective January 1, 2018. Temporary rules became effective February 1, 2018 to implement the SMFP. Permanent amendments are now proposed to existing Certificate of Need rules to compliment or be made consistent with the 2018 SMFP. The proposed rule addresses the definitions for the criteria and standards for CON Surgical Services and Operating Rooms proposals. The changes include clarification and alphabetization of the definitions, deletion of non-applicable terms used in the rules in this Section, and addition of definitions to reference the terminology in the SMFP.
