The state board is very vague with this rule as to what it will accept and not accept and what happens if the state board does not agree with what the party has done or said to meet the requirement of general purpose and intent.

Furthermore, multiple minor parties have already begun their petition drives and changing the rules in the middle of their drives is unfair to those parties.
