The Environmental Management Commission (EMC) submits the following information for 15A NCAC 02B, 15A NCAC 02H, 15A NCAC 02T, and 15A NCAC 02U for the Rules Review Commission's consideration in setting the readoption deadline for these four subchapters.

The EMC proposes that the readoption deadline, including all steps required by G.S. 150B-21.2, be accomplished by completing the rulemaking in five groups as detailed below, with a final adoption deadline for all rules in 15A NCAC 02B, 15A NCAC 02H, 15A NCAC 02T, and 15A NCAC 02U by **June 1, 2029**.

For ease of reference, a table listing each of the five proposed groups and readoption deadlines is included after the narrative rulemaking priorities and rationale below.

### **Rulemaking Priorities and Rationale**

Collectively, these four subchapters have 354 rules categorized as necessary and requiring readoption. The readoptions will be completed in five groups, with similar grouping and order as the first round of readoptions. A description of each group, along with the rationale, is provided below

### Group A: 36 rules in Subchapters 02B and 02H

#### Proposed Readoption: January 2027

These rules covering all stormwater programs are implemented by the Division of Energy, Mineral and Land Resources (DEMLR). We propose to keep all the DEMLR stormwater rules in one rulemaking package and separate from other division's rules. This is more efficient for staff, the commission, and the regulated community.

## Group B: 25 rules in Subchapters 02B and 02T

### Proposed Readoption: May 2027

This group will include two separate rulemaking packages running concurrently.

The 7 rules in 02T covering soil remediation are implemented by the Division of Waste Management (DWM). DWM staff are interested in completing this readoption quickly as this the bulk of their rules (15A NCAC 02L, 02N, 02O and 02P) are also beginning the periodic rule review, with designation reports due to the RRC in August 2025.

The 18 rules in 02B covering the Falls Lake and Jordan Lake Nutrient Management Strategies are implemented by the Division of Water Resources (DWR). These rules were not readopted during the first round due to SL 2016-94. DWR and stakeholders have been working on these strategies together and have established them as a priority to be readopted by mid-2027.

# Group C: 124 rules in Subchapters 02T and 02U

### Proposed Readoption: May 2028

These rules covering waste not discharged to surface water programs and the reclaimed water program are implemented by DWR. We propose to keep all of these programs in one rulemaking package and separate from the other DWR rules. This is more efficient for staff, the commission and the regulated community without overwhelming anyone with too many rules at once.

## Group D: 46 rules in Subchapter 02B

### Proposed Readoption: November 2028

These rules covering surface water quality standards and classifications are implemented by DWR. We propose to keep all of these programs in one rulemaking package and separate from the other DWR rules as they are part of the federally required Triennial Review of Standards. These rules must be submitted to EPA for review and approval.

# Group E: 123 rules in Subchapters 02B and 02H

### Proposed Readoption: May 2029

These rules cover several programs (NPDES, Pretreatment, Lab Certification, 401 water quality certifications, Neuse, Tar-Pamlico and Randleman Lake Nutrient Management Strategies, and the Catawba and Goose Creek Management Strategies) and are implemented by DWR. We propose to keep all of these programs in one rulemaking package and separate from the other DWR rules. This is more efficient for staff, the commission and the regulated community without overwhelming anyone with too many rules at once.
