In reviewing this Rule, the staff recommends the following changes be made:

Throughout the Rule, for the Index No. references, it is correct to remove the parenthesis. Would it be clearer to set these references off with commas before and after?

The decision to remove the parentheses for the Index No. references for this Rule was made because the Rules Review Commission counsel requested their removal in a similar, recently codified rule: 15A NCAC 02B .0315 Neuse River Basin. Therefore, this rule was formatted to be consistent to 02B .0315.

Several parentheses were removed. If possible, please remove the parentheses in Subparagraph (d)(2) and Paragraph (g).

Requested changes made. Paragraph (g) has been rewritten without parentheses.

"All" should not be used if "a", "an", or "the" can be used with the same meaning or if the word can be omitted. This appears on page 2, lines 7 and 15.

Requested changes made. "All" has been removed the Rule.

"Appropriate" should be avoided if possible. This appears on page 2, line 11.

Requested changes made. Paragraph (g) has been rewritten without the word "Appropriate".

In Paragraph (g), "In some cases" and "In other cases" seems unnecessary. Please remove.

Requested changes made. Paragraph (g) has been rewritten without these phrases.

Please retype the rule accordingly and resubmit it to our office electronically.
