- February May 2025: Stakeholder consultations on draft rule language
- June September 2025: Staff to complete proposed rule amendments
- October 2025 January 2026: Staff to develop fiscal analysis and obtain OSBM approval
- March 2026: EMC's Water Quality Committee to consider draft rules and fiscal analysis to proceed to the full EMC.
- May 2026: Full EMC to approve proposed rules and fiscal analysis to proceed to public comment and hearing
- Late May 2026: File Notice of Text to OAH for publication in NC Register
- Late June Late August 2026: Public comment period
- September November 2026: Staff to develop Hearing Officer's Report (HOR)
- January 14, 2027: Environmental Management Commission to adopt the rules, approve the HOR including the fiscal analysis at its regularly scheduled meeting
