With input from a stakeholder workgroup, substantial revisions have been made to this Rule for readoption to refer the requirements for licensees who use industrial radiography sealed sources and for industrial radiographic operations safety requirements to the federal Code of Federal Regulations (CFR) in 10 CFR 34, with exceptions to the CFR as identified in the Rule. Explain: Continuing Education (CE) does not align with requirements for Nurse Practitioners nationally nor does it align with the continuing education requirements for NC Physician’s Assistants under a similar structure. North Carolina requires more continuing education of their Nurse Practitioners than any other state, with Illinois the closest state requiring 40 hours annually. Additionally, Nurse Practitioners in North Carolina are required to have more continuing education than any other licensed healthcare professional in this state. The clinical pharmacist is the next closest in requiring 35 hours annually. The proposed amendment would require 50 contact hours of continuing education every 2 years as opposed to every year. This amendment also specifies maintaining national certification as defined in 21 NCAC 36 .0801(8) will meet the continuing education requirements for Nurse Practitioners biennially.


