9B. Explanation of Reason for Action

The Board adopted this rule to accommodate standardized orders in health care pharmacy settings (such as hospitals and long-term care facilities). Standardized orders are ones that allow a health care facility pharmacist-manager to establish criteria for ordering medications that are determined to be safe for all patients meeting those criteria, regardless of any drugs, supplements, or other substances that might have been consumed by those patients. Because of the absence of any relevant distinction among those patients, the medications would be able to be dispensed without patient-specific drug regimen review being performed. This rule was the product of study by a working group that included members from a wide variety of health care pharmacy settings.

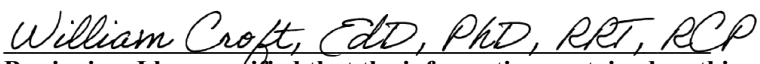

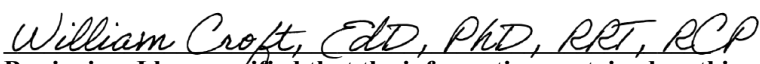
