


Explain: The SBE adopted 16 NCAC 06E .0204 Interscholastic Athletics and Administering Organizations for High School Athletics as a temporary rule at its March 3, 2022, meeting and it was published as a temporary rule in the NC Register on July 15, 2022. Aside from corrections of punctuation and syntax, the-proposed permanent rule is identical to the temporary rule except that in response to public comment paragraph (k) has been amended to explicitly authorize an administering organization to waive any student eligibility requirement contained in the rule if a waiver is necessary to reasonably accommodate a student’s disability, as required under the Americans with Disabilities Act (ADA), U.S.C. §12101 et seq. Participating high schools and administering organizations must comply with the ADA in any case but the explicit authorization to issue waivers to accommodate students’ disabilities will remind students and administrators of their rights and obligations under that law.

<p>At the outset of the COVID-19 pandemic in March 2020, the North Carolina Secretary of Health and Human Services and the State Health Director proposed that the Boards of Pharmacy and Nursing and the Medical Board adopt a COVID-19 Drug Preservation Rule. At that time, there were many drugs with a suspected potential to treat COVID-19. The rule was drafted to ensure that a supply of those drugs also remained available for patients who were prescribed those drugs for other conditions. On August 15, 2022, the declared state of emergency ended in North Carolina. With that change, the North Carolina Secretary of Health and Human Services and the State Health Director have agreed that there is no current need for this rule. The Board of Pharmacy understands that the Medical Board and the Board of Nursing are in the process of repealing their analogous rules.</p>
