





Explain: This is one proposed rule in a group of 11 proposed rules in 15A NCAC 03 and 18A that make conforming changes to remove outdated shellfish relay requirements to reflect the discontinuation of the Division of Marine Fisheries Shellfish Relay Program. Proposed amendments to this Rule also move three defined terms to 15A NCAC 03O .0201 and update them consistent with Session Law 2019-37, Section 3, to apply to that section of rules about shellfish leases and franchises. A conforming change is also proposed to Subparagraph (5)(k) to remove Elizabeth City from the definition of "Office of the Division" since the license office there is permanently closed; the remaining offices are also proposed to be listed in geographic order from south to north.

REASON FOR ACTION FOR ADOPTION OF 21 NCAC 46 .2516


North Carolina law requires pharmacies both to post the hours that they are open and to ensure that adequate staffing is available to render services to the public safely during those hours. The Board is aware of a number of times that pharmacies have been forced to close temporarily due to emergencies, including unanticipated staffing shortages. While pharmacies should be able to close temporarily in order to ensure that their practice is consistent with the public health, safety and welfare, patients may be delayed in receiving needed medications. The proposed rule would ensure that permit holders may appropriately manage their pharmacies while providing an avenue for patients to be informed of temporary closings and to receive their prescriptions elsewhere, if needed.

During the notice-and-comment period, the Board received one comment – from the North Carolina Retail Merchants Association – proposing certain clarifications to the amendment. The Board adopted the technical changes to the rule in response to the suggestions from that association representing regulated persons. Each of these changes clarifies the intent that the Board had for the rule, namely: (1) that the rule not apply to very short term closures, such as when a pharmacist might be delayed in traffic, that are not likely to disrupt patient care; (2) that the patient be allowed to select the pharmacy to which the patient’s prescription is transferred (if at all); (3) that transfers not be required if there is no available person who can legally transfer the prescription (which is the set of persons listed in the changes); and (4) that the procedures in the rule do not apply in a state of emergency, when compliance could endanger personnel.


