The North Carolina Irrigation Contractors' Licensing Board ("Board") held a regularly scheduled meeting yesterday, November 13, 2024. During this meeting, the Board approved the following plan to complete the readoption of its "necessary" rules pursuant to 26 NCAC 05 .0212(c) by the suggested deadline of <u>December 1</u>, <u>2026</u>.

The Board meets quarterly and currently has four meetings scheduled for 2025. During the first meeting, as legal counsel, I intend to reiterate the general purpose and importance of rules and in particular the Periodic Rule Review and readoption process, as the Board will have multiple new members. The entire Board will then spend the next 3-4 meetings systematically reviewing all of its 35 rules, making any changes, considering any fiscal implications, etc. The Board intends to publish its rules in Spring of 2026, allowing plenty of time for a thorough review of all public comments and incorporate public input. This schedule would also allow the Board to have sufficient time to make substantive changes and re-publish, if necessary, before submission to the Rules Review Commission.

Thank you for the email and the updated information. The deadline of December 1, 2024, is for your agency to submit the information required in 26 NCAC 05 .0212(a) to the RRC. December 1, 2026, is the suggested deadline for your agency to complete the readoption of all your "necessary" rules pursuant to 26 NCAC 05 .0212(c). Please see below and let me know if you have any questions.

26 NCAC 05 .0212 READOPTIONS:

(a) When setting a readoption deadline pursuant to G.S. 150B-21.3A(d)(2), an agency that is not a board or commission shall, within 60 days of receipt of the Commission's consultation request, submit to the Commission: (1) written documentation of the agency's planned timeline for readoption, providing planned dates for all steps required by G.S. 150B-21.2; and (2) written documentation of any of the agency's rulemaking priorities that the agency determines to be relevant to the timeline for readoption.

(b) A board or commission shall take the actions specified in Subparagraphs (a)(1) and (a)(2) of this Rule within 60 days of receipt of the Commission's consultation request, or within 10 days after the board or commission's next regularly scheduled meeting after receipt of the Commission's consultation request, whichever comes later.

(c) To meet the readoption deadline established pursuant to G.S. 150B-21.3A(d)(2) and Paragraphs (a) or (b) of this Rule, an agency, board, or commission shall: (1) adopt the rule, as defined in G.S. 150B-2(1a), by the date established pursuant to G.S. 150B21.3A(d)(2) and Paragraph (a) or (b) of this Rule; and (2) file the rule with the Commission within 30 days of adoption.
