Dear Mr. Ascher:

The Department of Labor is committed to a substantive review of its existing rules during the decennial review process. As a result, the Department is submitting an overall regulatory reform plan for consideration by the Rules Review Commission. The Department of Labor intends to use the periodic review process as an opportunity to modernize outdated rules and establish balanced, common-sense solutions to any regulations that are unduly burdensome on businesses operating in this State.

To ensure the Department reviews its most important rules in a timely manner, the Department asks the Commission to consider the plan for regulatory reform in its entirety. This plan identifies rules by three "groups" based on the Commission's schedule of reports but re-arranges the order in which those groups will be readopted.

The Department is requesting the following readoption deadlines:

13 NCAC 15 and 20 ("Group 2")

13 NCAC 07 and 12 ("Group 3")

13 NCAC 01, 04, 06, 13, 16, 17, and 19 ("Group 1")

January 1, 2027

June 1, 2028

April 1, 2030

The Commissioner of Labor approved the attached timelines showing the Department's plan for regulatory reform on April 14, 2025. Thank you for your consideration.

I did have a question:

For group 1, it looks like you've got a typo. As written, your filing for the register in November 2029 then adopting and filing for RRC review in March 2029. That won't work. However, I am not sure if you meant to file for register in November 2028 with final adoption in March 2029 or file for the register in November 2029 with final adoption in March 2030. I think either is reasonable, but please update your timeline and letter to make sure they match your request.

Ashley,

The attached periodic review reports have been finalized. The next step is to set a deadline for the readoption of these rules. Pursuant to G.S. 150B-21.3A and 26 NCAC 05 .0212, the RRC sets this deadline after consultation with the agency, and this email serves as the RRC's request for that consultation. Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

It appears that the deadline for your agency to provide this information is April 25, 2025. As a starting point, I would recommend an April 1, 2027 readoption deadline, but I am open to considering a different recommendation based on the needs of your agency.
