After further consultation, the Manufactured Housing Board has decided to accept the initially proposed readoption deadline of February 1, 2027. In light of that readoption deadline, we anticipate publishing notice of the proposed text of the rules in the first quarter of 2026 to allow for a robust public comment period and – if the Board decides to make substantial changes to the rules following that public comment period – enough time to republish the rules and proceed through a second public comment period. Pursuant to G.S. 150B-21.2(e), the public hearing will be held at least 15 days but not later than 60 days from publication. The Board will then adopt the rules after the expiration of the public comment period.

Please let me know if this email provides all the details regarding the Manufactured Housing Board's planned timeline for readoption required by 26 NCAC 05 .0212.

Kyle,

It's okay if your agency completes the required steps in advance of the readoption deadline, however, the RRC may not be able to review and vote on your readopted rules before the agreed upon deadline. Any agency that seeks to have their rules considered by RRC before their deadline will be at the mercy of rules that have earlier deadlines.

Please be mindful of 150B-21.2(g) when spreading out your readoption timeline. That is, once you publish a rule in the Register, it starts the 1-year clock for adoption, or the publication expires. I expect the RRC will be mostly concerned with enforcing the actual readoption deadlines and the timing requirements for rules in 150B.

In terms of submitting your rules to RRC early, it would be preferrable for us if agencies follow their submitted timelines. If you desire a date less than two years in the future, we can likely agree to that date at this time.
