Attached is 15A NCAC 03O .0603, this is intended to incorporate by reference only the suspension procedures found in the manual and add the URLs to the two agency websites that are currently proposed in 15A NCAC 03O .0602. The agency is requesting to withdraw 15A NCAC 03O .0602 in accordance with 26 NCAC 05 .0107. As such, below are responses to your most recent questions that pertain to the requested withdrawal of 15A NCAC 03O .0602 and proposed technical changes to 15A NCAC 03O .0603.

On line 7, I was unable to find where at <http://www.wildlife.org> one could find the compact manual. WRC staff relayed they have restored a broken link on the “Enforcement” page of the agency website and updated the URL to end with “.gov”. The website link for each agency is proposed to be added to 15A NCAC 03O .0603(c) on lines 17-18.

Within the manual, identify with specificity the necessary requirements prescribed upon anyone who the agency has authority over. Put a simpler way, who are you regulating and what are you telling them to do?

[The suspension procedures incorporated by reference in 15A NCAC 03O .0603\(c\) \(starting on line 15\) place requirements on the home state, member states, and the violator.](#)

Considering the WFC, to which the State has already entered, and Article 22B of Chapter 113, why is the incorporation of the manual , portions of it or in toto, reasonably necessary pursuant to G.S. 150B-21.9(a)(3)?

[The Wildlife Violator Compact Operations Manual contains numerous detailed requirements about suspension procedures that accommodate the different ways member states, including their respective courts, proceed with suspension of privileges and the associated documentation. G.S. 150B-21.6 allows an agency to incorporate this material by reference without repeating the text of the referenced material.](#)

Hope you are doing well. The agency appreciates the RRC extending the period of review for 15A NCAC 03O .0601-.0606 at its April 24 meeting. Agency staff met this morning to discuss the remaining requests for technical changes to the rules. In regard to your questions below about 15A NCAC 03O .0603, lines 7-10, the agency provides the following response:

The paragraph is necessary and applies to non-residents, not residents of North Carolina. The requirement makes clear for inspectors and protectors that custodial arrest is not required. Before the Interstate Wildlife Violator Compact, in the case of charging a non-resident with a fisheries violation, the general practice required the non-resident's arrest to encourage compliance with fisheries laws and local courts. This was the practice in many jurisdictions across the country.

One of the benefits of the Interstate Wildlife Violator Compact is knowing that if an officer cites and releases a non-resident on personal recognizance, if the violator does not comply there is the consequence of facing a suspension in their home state. This provides an officer a larger level of confidence that the violator would comply than prior to the Compact being enacted in North Carolina.

Consistent with the definitions added to 15A NCAC 03O .0601, the word "offenses" has been replaced with the word "violations" and the remaining text has been simplified.

*Line 5: Define "inspector."*

G.S. 113-128(5) defines "inspector".

*Line 8: Change "may" to "shall" or state the criteria which will be used in exercising the discretion.*

The use of "may" in N.C. General Statutes pertaining to marine and estuarine resources provides authority for inspectors to exercise discretion to arrest, swear out warrants, issue citations, and other similar activities (see statute references below). The use of "may" in the proposed rule is intentional and is consistent with North Carolina law. A real-world example could consist of a recreational fisherman from South Carolina who comes to North Carolina and takes clams from a polluted area. Upon interviewing the person, the inspector learns the person did not know the area was closed and did not intend to take clams from a polluted area. An inspector would likely issue a citation to the person and release them on their own recognizance. Conversely, a commercial fisherman from South Carolina comes to North Carolina and takes a bag of clams from a polluted area to sell them, in which case the inspector would need the discretion to not release that person to be able to stop them from continuing with the sale of those clams that could cause harm to human health if consumed.

Criteria are impractical to articulate here because an inspector's decision is based on the totality of the circumstances. Consistent with G.S. 15A-401(b), these circumstances can include an inspector having probable cause to believe the violator would not appear in court or that the violation would be repeated if the violator is not arrested.

G.S. 113-136: "(d) Inspectors and protectors are additionally authorized to arrest without warrant under the terms of G.S. 15A-401(b) for felonies, for breaches of the peace, for assaults upon them or in their presence, and for other offenses evincing a flouting of their authority as enforcement officers or constituting a threat to

public peace and order which would tend to subvert the authority of the State if ignored. In particular, they are authorized, subject to the direction of the administrative superiors, to arrest for violations of G.S. 14-223, 14-225, 14-269, and 14-277."

G.S. 113-136: "(e) Inspectors and protectors may serve arrest warrants, search warrants, orders for arrest, criminal summonses, subpoenas, and all other process connected with any cases within their subject-matter jurisdiction. In the exercise of their law enforcement powers, inspectors are subject to provisions relating to police officers in general set out in Chapter 15, Chapter 15A, and elsewhere."

G.S. 113-137: "(b) Every inspector or protector who issues a citation instead of arresting a person, in cases in which the inspector or protector is authorized to arrest, may seize all lawfully discovered evidence, fruits, and instrumentalities of any crime as to which he has arrest jurisdiction and probable cause."

(d) Pots attached to shore or a pier shall be exempt from Subparagraphs (a)(2) and (a)(3) of this Rule.

(e) It shall be unlawful to use shrimp pots with mesh lengths smaller than one and one-fourth inches stretch or five-eighths-inch bar.

(f) It shall be unlawful to use pots ~~to take eels~~ with mesh lengths smaller than one-half inch by one-half ~~inch~~ inch ~~to take eels.~~

(g) Except for unbaited pots or pots baited with a male crab, it shall be unlawful to use crab pots in Coastal Fishing Waters unless each pot contains no less than three unobstructed escape rings that are at least two and five-sixteenth inches inside diameter and:

(1) for pots with a divider:

(A) two escape rings shall be located on opposite panels of the upper chamber of the pot; and

(B) at least one escape ring shall be located within one full mesh of the corner and one full mesh of the bottom of the divider in the upper chamber of the pot.

(2) for pots without a divider:

(A) two escape rings shall be located on opposite panels of the pot; and

(B) at least one escape ring shall be located within one full mesh of the corner and one full mesh of the bottom of the pot.

For the purpose of this Rule, a "divider" shall mean a panel that separates the crab pot into upper and lower sections.

(h) The Fisheries Director may, by proclamation, impose on a commercial fishing operation and for recreational purposes any of the following restrictions for pots:

(1) specify time;

(2) specify area;

(3) specify means and methods;

(4) specify record keeping and reporting requirements;

(5) specify season, including a closed season for removal of all pots from Internal Waters;

(6) specify species; and

(7) specify ~~quantity~~ quantity of species taken.

(i) It shall be unlawful to use more than 150 crab pots per vessel in Newport River.

(j) It shall be unlawful to remove crab pots from the water or remove crabs from crab pots between one hour after sunset and one hour before sunrise.

(k) It shall be unlawful to use pots to take crabs unless the line connecting the pot to the buoy is non-floating.

(l) It shall be unlawful to use pots with leads or leaders to take shrimp. For the purpose of this Rule, "leads" or "leaders" shall mean any fixed or stationary net or device used to direct fish into any gear used to capture fish. Any device with leads or leaders used to capture fish shall not be a pot.
