3 **15A NCAC 10C .0101 SCOPE AND PURPOSE**

4 The following rules pertain to the classification of the waters of North Carolina as coastal fishing waters, inland fishing  
5 waters and joint fishing waters. These rules are adopted jointly by the Marine Fisheries Commission and the Wildlife  
6 Resources Commission. In addition to the classification of the waters of the state these joint rules set forth guidelines  
7 to determine which fishing activities in joint waters are regulated by the Marine Fisheries Commission and which are  
8 regulated by the Wildlife Resources Commission. Finally, the joint rules set forth special fishing regulations  
9 applicable in joint waters that can be enforced by officers of the division of marine fisheries and the Wildlife Resources  
10 Commission. These regulations do not affect the jurisdiction of the Marine Fisheries Commission and the Wildlife  
11 Resources Commission in any matters other than those specifically set out.

3 **15A NCAC 10C .0102 INLAND FISHING WATERS**

4 Inland fishing waters are all inland waters except private ponds; and all waters connecting with or tributary to coastal  
5 sounds or the ocean extending inland from the dividing line between coastal fishing waters and inland fishing waters  
6 agreed upon by the Marine Fisheries Commission and the Wildlife Resources Commission. All waters which are  
7 tributary to inland fishing waters and which are not otherwise designated by agreement between the Marine Fisheries  
8 Commission and the Wildlife Resources Commission are inland fishing waters. The regulation and licensing of  
9 fishing in inland fishing waters is under the jurisdiction of the Wildlife Resources Commission. Regulations and laws  
10 administered by the Wildlife Resources Commission regarding fishing in inland fishing waters are enforced by  
11 wildlife enforcement officers.

12 Note: A private pond is a body of water arising within and lying wholly upon the lands of a single owner or a single  
13 group of joint owners or tenants in common, and from which fish cannot escape, and into which fish of legal size  
14 cannot enter from public waters at any time. This does not include any impoundment located on land owned by a  
15 public body or governmental entity.

6 fishing waters, coastal fishing waters, or joint fishing waters shall be marked with signs insofar as may be practicable.  
7 Unmarked and undesignated tributaries shall have the same classification as the designated waters to which they  
8 connect or into which they flow. No unauthorized removal or relocation of any such marker shall have the effect of  
9 changing the classification of any body of water or portion thereof, nor shall any such unauthorized removal or

4 **[The following requirements shall apply in joint fishing waters and]** In order to effectively manage all fisheries  
5 resources in joint waters and in order to confer enforcement powers on both **marine fisheries inspectors enforcement**  
6 **officers and wildlife enforcement officers** with respect to certain rules, the Marine Fisheries Commission and the  
7 **Wildlife Resources Commission** deem it necessary to adopt special rules for joint waters. Such rules supersede any

25 management area in which the individual is found to be fishing, regardless of the size or  
26 creel limits for other management areas visited by that individual in a given day.  
27 (g) **It is [it shall be]** unlawful to engage in net fishing for striped bass or their hybrids in joint  
28 waters except as authorized by rules of the Marine Fisheries Commission.

29 (2) Lake Mattamuskeet

- 30 (a) **It is [it shall be]** unlawful to set or attempt to set any gill net in Lake Mattamuskeet canals  
31 designated as joint waters.  
32 (b) **It is [it shall be]** unlawful to use or attempt to use any trawl net or seines in Lake  
33 Mattamuskeet canals designated as joint waters.

34 (3) Cape Fear River. It **is [shall be]** unlawful to use or attempt to use any net, net stakes or electrical  
35 fishing device within 800 feet of the dam at Lock No. 1 on the Cape Fear River.

36 **(4) Shad: It is [shall be] unlawful to possess more than 10 American shad or hickory shad, in the**  
37 **aggregate, per person per day taken by hook-and-line.**

8 a single instrument in the following management areas:

9 (1) In the Roanoke River Management Area, the exclusive authority to open and close seasons and areas  
10 and establish size and creel limits, whether inland or joint fishing waters, shall be vested in the  
11 Wildlife Resources Commission. An instrument closing any management area in joint waters shall  
12 operate as a jointly issued instrument opening or closing seasons or areas to harvest in the Roanoke

11 (C) within 50 yards of the Fifth Street Landing Boating Access Area, 1919 W. Fifth Street,  
12 Roanoke Rapids.

13 (2) Roanoke River.

14 (A) Within 50 yards of the Weldon Boating Access Area, 1090 Rockfish Lane,  
15 Weldon; and

16 (B) within 50 yards of the Edwards Ferry Boating Access Area, 89 U.S. Highway 258,
