Pursuant to G.S. § 150B-21.3A(d)(2), select rules were readopted in 2019 to implement some of the changes instigated by the 2018 statutory changes. With the current proposed adoptions, amendments, and repeals, the North Carolina Board of Dietetics/Nutrition (hereinafter "the Board") seeks to align all of its rules with the statutory authority provided in Article 25, Chapter 90, ensure clarity, streamline the application process, and ensure its ability to continue operations. <b>9B. Explain:</b> The agency updated the number of CEUs throughout the rule to reflect the new definition of "CEU" in Rule .0404. The amendment increases the number of years before electrologists have a different requirement for CEUs, and the amendment clarifies how time periods will be measured. For clarity, the board changed the phrase "renewal period" to "license effective period." The amendment requires new licensees to renew licenses and pay for inspections for the upcoming year, and specifies that an initial license will not be issued until an initial inspection of the practicing office takes place. The agency originally proposed to limit carry-over CEUs to in-person seminars. At the request of a public comment, the board allowed carry-over CEUs to include virtual learning (referred to in the rules as "home study"). Also at the request of a public comment, the board set reasonable requirements to verify that an attendee actually participates in the CEUs.
