In reviewing this Rule, the staff recommends the following changes be made:

Generally, to the Rule: Explain why the changes made in between publication of the proposed rule and the adoption of the rule do not require re-publication. See 150B-21.2(g).

Line 5, (a): What does the Commission mean or intend by "accredits"? In 12 NCAC 10B .0804 the Commission has a process for accreditation. Does the NC Justice Academy get to bypass Rule .0804?

Line 7, (b): Strike "approximate".

Lines 21-26, (c): Pursuant to G.S. 17E-4, the Commission shall develop the standards for training. Here the Commission appears to delegate that authority to a "developer" without further review or ratification. Explain the Commission's authority.

Lines 32-37, (e): Here the Commission is requiring schools to "adhere to" by a "guide" which has not been adopted under the Administrative Procedures Act. Explain the Commission's authority.

Line 1-4, (f): To what "pre-delivery report" is the Commission referring? Is this the Form F-7A-T from 12 NCAC 10B .0709? If so, what rule has been adopted which addresses the mandatory content of the form? See G.S. 150B-2(8a)(d)
