Nadine,

After consulting with my colleagues, I stand by the interpretation raised in my initial RFC. That is, because G.S. 150B-21.1(a4) specifically requires that “[t]he statement [of need] must be signed by the head of the agency adopting the temporary rule,” the general provisions in G.S. 143B-10 do not allow for the delegation of signing the statement of need. Here, if the statement of need is not signed by the “head of the agency adopting the temporary rule,” I will have to issue a staff opinion identifying this issue for the Commission.

I recognize that the language in box 10 of the “Temporary Rule-Making Findings of Need” form could be misleading. Regardless of what happens with these particular rules, I will discuss clarifying the form with the Commission Chair and updating guidance to rule-making coordinators.

Separately, if you want to stand by the delegation, I will also need to advise the Commission that the delegation form is unsigned. I am happy to give the Commission the additional context that this is a directive that is posted on the NCDHHS website, but that does not eliminate the need for a signature.

Both of these issues would be cured by having the “head of the agency” sign the statement of need. If the agency does not choose to correct the signature before the Commission meeting, and assuming any other issues are resolved, I could recommend approval conditional upon correcting the signature. I cannot speak to whether that is the action the Commission would decide to take.
