Regarding 21 NCAC 18B .0213, the rule number on line 4 also needs to be updated. That text does not need to be underlined or highlighted. Also, include an updated cover form with the correct rule number and reflecting adoption when you resubmit. On line 18 in the history note, it should also read "adopted" instead of "amended".

Regarding 21 NCAC 18B .0308, add "History Note:" on line 10 preceding "Authority" similar to your other rules. I missed that on my first review.

With those small changes, you should be good to resubmit. As we discussed, I anticipate recommending that the Commission approve all three of these rules and will let you know if something changes between now and the meeting.
