Last readoption schedule:

May 2026 – Jan 2028 work with advisory committees, working groups of agencies and stakeholders to amend rules, finalize amendments

Feb 2028 – Nov 2028 - work with OSBM to complete fiscal note and get it approved

Dec 2028 – get approval from Social Services Commission to initiate rulemaking

Jan 2029 – get approval of rules and fiscal note from Dr. Dev Sangvai to submit to OAH

March 2029 – June 2029 – submit rules to OAH, publish in Register, send interested parties notices, 60 day comment period

July 2029 – Aug 2029 – Address comments

Sept 2029 – Get approval at Social Services Commission quarterly meeting to send rules to RRC

Oct 2029 – Dec 2029 – send rules to Governor Josh Stein for approval

Jan 2030 submit rules to RRC

Feb 2030 RRC approval

March 1, 2030 effective date.
