Please find below the proposed readoption schedule for rules under 11 NCAC 11F on behalf of the Department of Insurance after accepting the proposed deadline of November 1, 2029. The dates shown in this timeline are projected deadlines and do not reflect specific dates.

Initial Review for Readoption: *January 2029*
Publication of Notice of Text: *January 2029*
Public Hearing: *At least 15 days but no later than 60 days after notice of text is published*
Public Comment Period: *January/February 2029-April 2029*
Final Readoption: *April 2029*
Submission of rules to OAH for RRC consideration: *April -October 2029*
RRC Review: *No later than October 2029*
Earliest Effective Date of Rules: *November 1, 2029*

I am open to considering a different readoption deadline based on the needs of your agency.
