Please find the proposed readoption schedule for rules under 11 NCAC 4 and 11 NCAC 12 on behalf of the Department of Insurance after accepting the offered deadline of **May 1, 2030**. The dates listed in the below timeline indicate projected deadlines and do not reflect specific dates for the agency.

Initial Review for Readoption: *July 2029*
Publication of Notice of Text: *July 2029*
Public Hearing: *At least 15 days but no later than 60 days after notice of text is published*
Public Comment Period: *July/August 2029 - October 2029*
Final Readoption: *October 2029*
Submission of rules to OAH for RRC consideration: *October 2029 - April 2030*
RRC Review: *No later than April 2030*
Earliest Effective Dates of Rules: *May 1, 2030*

Please let me know if any additional information is needed for this proposed readoption schedule of 11 NCAC 04 and 11 NCAC 12 rules.

Pursuant to G.S. 150B-21.3A and 26 NCAC 05 .0212, the RRC sets this deadline after consultation with the agency, and this email serves as the RRC's request for that consultation. Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

The deadline for your agency to provide this information is **August 18, 2026**. As a starting point, I'm proposing a couple readoption deadlines options for your consideration: **May 1, 2030 or August 1, 2030**. I am open to considering a different readoption deadline based on the needs of your agency.
