

**RULES REVIEW COMMISSION MEETING
MINUTES
November 17, 2022**

The Rules Review Commission met on Thursday, November 17, 2022, in the Commission Room at 1711 New Hope Church Road, Raleigh, North Carolina, and via WebEx.
