#### To whom it may concern:

I am writing in response to the ruling NCAC 16H.0105 DENTAL RADIOLOGY COURSE AND EXAMINATION REQUIREMENTS. I feel it is incredibly important that North Carolina understand the deficiency of Dental Hygienists and Dental Assistants as stated by the ADA in October 2022, "HPI, along with the American Dental Hygienists Association (ADHA) and the Dental Assisting National Board (DANB), explored the serious workforce shortage the dental sector is facing. In any given month, four out of ten dental practices are trying to hire dental assistants or dental hygienists". Proprietary dental assisting schools can be a solution to this shortage.

I have served as a dental assisting instructor for Accelerated Academy in North Carolina since 2018. We have graduated 2700 students with a 98% hiring rate across the nation since the school began in 2011. I believe dental offices in North Carolina have been the beneficiaries of qualified DAI students. I am concerned about the ratio of students to teachers being reduced from 15:1 to 6:1 especially with the limited provision of classes for instructor credentialing in NC.

I would like to explain how I manage the didactic and clinical learning setting. Our classes provide 4 hours of didactic instruction for the morning and 4 hours of clinical instruction for the afternoon. The lecture is easily managed by one instructor offering student interaction and opportunity for questions. The clinical setting is supervised by 2 instructors. The 15 students are divided into 3 groups. All clinic station tasks for learning are closely monitored. My clinical assistant and I rotate every 10-15 min between the stations. I focus most of my time with the students taking radiographs on a mannequin. I train and observe technique, safety and diagnostic quality. This structure provides for a rich learning environment with constant supervision. A 15:1 ratio is very appropriate for learning proficiency.

I am asking that you would not approve the drastic reduction of student to teacher ratio. We are graduating qualified and hirable students that are passionate about their new field of healthcare. With the deficiency of qualified assistants in North

Carolina, our state needs our school.

Thank you for reconsidering this proposal and I ask that you consider looking at proprietary schools individually and familiarize yourself with what we offer and the knowledge base of the students we graduate.

To whom it may concern:

I am reaching out to express my objection to the proposed ruling 21 NCAC 16H. DENTAL RADIOLOGY COURSE AND EXAMINATION REQUIREMENTS. This ruling would require a 6:1 student to teacher ration instead of the current 15:1 ratio.

Currently I am teaching my 8th semester as a dental assistant instructor. The course I teach has a maximum capacity of 15 students and we meet for 10 weeks every Saturday. Each class consists of a 4 hour lecture and a 4 hour clinic with the exception of class 9, where students have an all day clinic. In addition, class 2 is dedicated to learning all things dental radiology. By the end of the course, students will have taken a minimum of 200 X-rays and completed 96 hours of job shadowing and training.

Every class I teach as a solo instructor has a strict checklist and guide. This ensures each student is comprehending every lesson and practicing essential hands on skills. One of the most important of these skills is taking X-rays and understanding dental radiology. Students are given the opportunity to learn both conventional and digital X-rays. By the end of the course each student has the ability to take diagnostic quality X-rays and is prepared to work in the dental field.

Working as a dental assistant for the past 10 years has enabled me to become extremely organized and an exceptional multitasker. With these skills, I am able to manage each student and their needs to ensure they are fully prepared to start their dental career. Under the current student to teacher ratio I have had the opportunity to teach 120 dental assisting students. If the student to teacher ratio is changed this will dramatically decrease class size and limit how many students I am able to help each year. I ask that you reconsider this proposal as it will not change the quality of the class I teach; it will only limit the number of students who have access to this course.



I am writing to ask for a review of the proposed ruling 21 NCAC 16H.0105 DENTAL RADIOLOGY COURSE AND EXAMINATION REQUIREMENTS made by the North Carolina Board of Dental Examiners, which is currently in the public notice phase.

I have concerns regarding the newly proposed ruling and requirements. Accelerated Academy hires instructors who have been in Dental Assisting for over twenty years but do not hold the UNC Chapel Hill Radiology Certification. The availability of this course is concerning as the course is only held one time per year and Accelerated Academy is only permitted to enroll three instructors per course. Accelerated Academy would love to have all of our instructors certified by the North Carolina Board of Dental Examiners' requirements, but how could we fulfill this only being able to send three instructors at a course held one time per year? If the need to hold the UNC Chapel Hill Radiology Certification is going to be an instructor requirement for licensing, please open additional class dates throughout the year and allow for more than three instructors to be enrolled.

Please consider my concerns regarding the UNC Chapel Hill Radiology Course or revisit including other Radiology Certification programs for instructors to attend.

I am writing to ask for a review of the proposed ruling 21 NCAC 16H.0105 DENTAL RADIOLOGY COURSE AND EXAMINATION REQUIREMENTS made by the North Carolina Board of Dental Examiners, which is currently in the public notice phase.

The concern in reading this proposed ruling is that there are still extremely vague portions that do not give adequate direction on how to achieve the requirements being put in place. All of my concerns revolve around the instructors teaching the proposed ruling. The qualifications of an instructor are only vaguely stated. (6) (A) revolves around CODA-accredited school courses; (6) (B) is what is extremely vague for proprietary schools that also would like to set our students up for success as dental assistants in NC. I will break down (6)(B) in portions below:

 An instructor who has "taken and passed a radiology instructor's certification course" taught by an instructor of dental radiography at a CODA-accredited institution..... What constitutes a radiology instructor's certification course: what content makes up this course? Is there a list of approved schools or courses offering this specific course that can be supplied by the board? If the board is requiring this, should it regulate or monitor who and how often these courses are offered so that this requirement can be met? Suggestions: A list of approved courses that meet this description posted on the board's website. Board review of the existing courses to make sure that courses are

board's website. Board review of the existing courses to make sure that courses are accessible often and following the vision of the board so that it is delivering what is required. Clear description of what this course entails so more CODA programs can offer a board approved course to the public. Enforcement that programs offer this course timely to meet demand in attendance.

2) "and has completed three hours of continuing education in the area of radiology every other year." Who maintains these records? Is this to be kept in an instructor's file and "produced upon the request of the board"? What constitutes an approved



CE course? Should the Board provide a description of what the course should be or provide a list of approved sponsors/courses for the acceptable CE hours ... or can the existing CE hours descriptions and lists that are currently on the board website under dentists and dental hygienists be used? Suggestion: clarify where to find a list of approved courses, where to store this information, and provide a description of what constitutes an approved course.

I am writing these objections from the perspective of a proprietary school operating dental assisting schools in your state that give students an alternative opportunity to longer, often more costly degree programs, to gain meaningful employment. We are a needed facet in this industry; but feel the Board has been extremely detailed in what they expect the students to know regarding radiology, but very vague in helping alternative programs to CODA schools provide quality instruction of the very content it is trying to protect and disseminate. Those following (6)(B) of this ruling need clear guidance on how to comply with the ruling.

I am writing to ask for a review of the proposed ruling 21 NCAC 16H.0105 DENTAL RADIOLOGY COURSE AND EXAMINATION REQUIREMENTS made by the North Carolina Board of Dental Examiners, which is currently in the public notice phase.

The concern in reading this proposed ruling is that there is not enough opportunity for an instructor to attend and pass a radiology instructor's certification course to meet the required 6:1 ratio. The only approved instructor radiology certification course is the *Educational and Clinical Application for Proprietary Radiology Educators* at UNC-Chapel Hill. There is limited opportunity for proprietary schools to enroll instructors in this course, to stay compliant with the board's requirements. Due to UNC-Chapel Hill not providing set dates for when the course is offered, it is difficult to enroll instructors in a timely manner. UNC-Chapel Hill limits seat availability to 3 people, per course. Only offering the course once a year, the last-minute announcement of the course date and the lack of seat availability hinders institutions from enrolling the necessary number of instructors to meet the 6:1 ratio. I would propose that UNC be held accountable to offer more than one course a year to meet demand or post the course dates in advance and offer a larger class capacity.

The requirement (3) states

"The laboratory portion of the course shall have no more than six students per instructor..."

### The requirement (6B) states

"An instructor who has taken and passed a radiology instructor's certification course taught by an instructor of dental radiography at a CODA-accredited institution, and has completed three hours of continuing education in the area of radiology every other year."

I would like to propose for the student: teacher ratio to be re-evaluated based off the lack of opportunity for teachers to attend an approved radiology course.



I am writing objections from the perspective of a proprietary school operating dental assisting schools in your state. Accelerated Academy has been successfully hosting dental assisting schools in the state of North Carolina since 2019. North Carolina has been one of the fastest growing states in our company due to the increased interest of doctors wanting to host our program to assist with the need of hiring dental assistants. Over the past four years, we have invested all attention to our operations to ensure we are providing an educational lecture environment, with a hands-on clinic approach with a 15:1 ratio of students to instructors while staying in compliance and ensuring our students have the necessary skills to work as a dental assistant.

We are a needed facet in this industry but feel the Board has proposed guidelines that will make it impossible for us to have enough instructors, with the right requirements to teach the number of students that enroll in our program throughout the state of North Carolina.
