Hey all,

Just to recap our conversation earlier today:

- 1. I cannot say at this time whether failure to comply with G.S. 150B-20 is something that would be remedied by the substantial compliance doctrine. I will continue to look into the issue and let you know, including possible remedies if the Commission objects.
- 2. The Medical Board's Submission for Permanent Rule Form needs to be amended to show that these rules were also adopted in response to a petition.
- 3. With respect to the 150B-19.1(c) issue on the Med Board's form, I think screenshots from your website, or really any documentary proof indicating you complied with the statute is all the Commission needs to see.
- 4. I am open to any further materials the Med Board or the Board of Nursing would like to submit, and will review anything you send before determining whether to recommend objection.
- 5. An agency can withdraw a rule at any time before a staff opinion is issued, and under 26 NCAC 05 .0107, an agency can withdraw a rule to which staff has recommended objection as long as the objectionable language is not part of the existing rule (i.e. if the proposed objection is only to new language).
