- December 16, 2024: NC Register issue published, beginning the public comment period.

- February 14, 2025: End of public comment period.
- February 21 March 28, 2025: Staff to develop Hearing Officer's Report (HOR).
- March 31 April 18, 2025: Oil and Gas Commission's Rules Committee to review draft HOR.
- End of April 2025: Oil and Gas Commission's Rules Committee to hold meeting to discuss the HOR.
- August 5, 2025: Oil and Gas Commission's regularly scheduled meeting to approve the RIA and adopt the rules.
