Travis,

Thanks for your note. The State Human Resources Commission agrees with the February 1, 2027 deadline that you recommended for the readoption of 25 NCAC 01A, 01B, and 01C.

Pursuant to 26 NCAC 05 .0212(a)(1), I have attached the HR Commission's planned timeline for readoption. This planned timeline for readoption was adopted by the HR Commission at its December 12, 2024 meeting.

26 NCAC 05 .0212(a)(2) calls for the agency to provide "written documentation of any of the agency's rulemaking priorities that the agency determines to be relevant to the timeline for readoption." On that topic:

- Because of limited staff, the most important rulemaking priority is to space out the readoption steps for Subchapters 01A, 01B, and 01C so that the HR Commission's staff are not doing the work to readopt all three subchapters at the same time.
 - The HR Commission proposes to start with Subchapter 01B, which is the most straightforward. This will allow HR Commission staff to learn the process and produce a better product for the Rules Review Commission's analysis when it is time for the more complex rules in Subchapters 01C and 01A.
- The proposed timeline stops in May 2026. This is intentionally several months before the proposed February 1, 2027 deadline for readoption. This is intended to allow enough time for any revised notices of text, and for any fiscal notes, that may be required in the process.
 - At the present time, HR Commission staff do not expect that a fiscal note will be required for any of the rules in Subchapters 01A, 01B, and 01C, because HR Commission staff expect that any revisions would impose a less stringent burden on regulated persons.
