(b) The Commission shall be responsible for the preparation, adoption, and amendment of the State guidelines. This rule would be easier to understand if it were broken into separate rules. At the least I would separate the (a) and (b) portions, the general and specific use standards. It seems to me that it would be easier still to find the specific use standards if each one of them were a separate rule addressing only the specific named uses in (b). If this were done please pay attention to the reference in (b)(11) page 15 line 23 to paragraph (a) of this rule and revise (a) and this reference as necessary.

In (a)(2)(A) line 19 the term "submerged aquatic vegetation as defined by the Marine Fisheries Commission" is used. It is repeated elsewhere in this rule. I do not believe that it is necessary to keep repeating "as defined by the Marine Fisheries Commission" in the subsequent references. It might also be better to move this definition, and make a reference to the specific source of the MFC definition, to the definition rule for the section or sub-chapter. [Note well: you could do this to the definition rule without prior notice or hearing for that rule if you were only moving the noticed language to a different rule and not making any other changes in that rule.

In (a)(3) page 2 line 7 either delete or define "clearly."

In (b)(1) page 3 line 5 delete or define "highly." As a matter of fact it may be that "highly productive" is not necessary since it appears that the rule concerns any "shellfish beds as identified by the MFC" unless the EMC includes in its designations the productivity of a designated shellfish bed, e.g. "low productivity shellfish beds … productive shellfish beds."

In (b)(1)(I) page 4 line 9 it seems to me the period at the end of the sentence should be a colon. This sentence on lines 8 and 9 could also be placed after (i) – (iv) at the same level as (I). In that case the period after "criteria" would become a semicolon.

In (b)(5) page 6 line 8 it seems to me that the word "also" in "shall also comply" is unnecessary.

In (b)(5)(A) page 6 line 12, it seems to me that you need to add the word "or" before "wetland habitats."

In (b)(5)(I) page 7 line 34 the commas after "... mooring sites (permanent or temporary), ... [and] reductions," should be changed to semicolons. As an alternative delete the commas in "... other device, either physical or regulatory," in lines 34 and 35.

In (b)(5)(K) page 8 line 1 the word "acceptable" is not necessary and should be deleted. Please verify that in line 2 you wish to refer only to (B) and not any of the other sub-sub paragraphs within this sub-paragraph (b)(1).

In (b)(5)(L) page 8 add "EMC" after "applicable" in line 5; in line 6 delete "as required by the EMC" and restore the period after "runoff."

In (b)(5)(M) page 8 line 9 it seems to me that "listing" or a similar term would be more likely to satisfy what appears to be the intent of this rule than "explaining."

In (b)(5)(Q) page 8 line 22 delete or define "to the maximum extent possible." It may be possible to satisfy this request by naming an official whose sole decision determines

whether something is or can be done "to the maximum extent possible." [See also the staff opinion concerning this requirement of the rule.]

Delete (b)(6)(C) in its entirety since the requirements in this rule appear to be contained in (b)(6)(A) and (C). As an alternative to this, you could choose to comply with the next two requests.

In (b)(6)(C) page 9 line 3 delete "shall be no wider than six feet and" since this requirement is already contained on the previous page in (A).

Likewise in (D) lines 14 and 15 delete "and shall be elevated ... from the bottom of the decking since this appears in (C) above.

In (b)(6)(E) page 9 line 17 delete or define "demonstrated." Perhaps "documented" might be a satisfactory substitution. I believe that in line 18 "only covering" would be more correct and read better as "covering only" although it might be possible that I don't understand the precise requirement.

In (b)(6)(F) page 9 line 23 delete or define "demonstrated." Perhaps "documented" might be a satisfactory substitution.

In (b)(6)(J) page 10 line 28 delete or define "to the maximum extent practicable." It may be possible to satisfy this request by naming an official whose sole decision determines whether something is or can be done "to the maximum extent practicable."

In (b)(8)(C)(iii) page 12 line 20 there needs to be a space in "... part(b)" Change "part" to "paragraph."

In (b)(8)(F) page 13 line 2 delete "during the life of the permit" to make it clear that the "life of the permit" does not include a permit renewal and subsequent or "repeated" beach nourishment." See also my staff opinion concerning this rule.

In (b)(10)(C) page 14 it seems to me that in line 2 "other" and "shall" are unnecessary and should be deleted. In line 3 "and vehicle" should be changed to "or vehicle" to make it clear that all three services are not necessary at that particular location.
