The Rules Review Commission staff has completed its review of this Rule prior to the Commission's next meeting. The Commission has not yet reviewed this Rule and therefore there has not been a determination as to whether the Rule will be approved. You may email the reviewing attorney to inquire concerning the staff recommendation.

In reviewing this Rule, the staff recommends the following changes be made:

Line 1, what are the specific "changes" to this Rule from what was published?

We deleted the word "by" in Paragraph (a). It was a small technical correction, so it was easy to overlook.

Line 5, is "At minimum" necessary? If so, why? If not, please delete it.

These are the minimum qualifications established by the SBE. As further explained in Paragraph (d), PSUs are free to impose additional qualifications under their inherent authority to set qualifications for their own employees not inconsistent with those established by the SBE or state law.

Line 5, add "(SBE)" after "Education".

I have made the change.

Lines 14 and 16, consider rephrasing (1) and (2) for clarity. i.e., "Within six months of beginning employment, or starting to work as a contractor for a PSU, successfully complete the ..."

I have rephrased those sentences to provide greater clarity.

Line 14, spell out "PSU" the first time it's used in a Rule.

Lines 21-23, what is your agency's authority to allow a PSU "to supersede the qualifications, training, or continuing education requirements for registered nurses under Chapter 90, Article 9A of the General Statutes"?

Upon further review, we have concluded that the language quoted above is superfluous and perhaps could be misinterpreted as allowing PSUs to set higher requirements for *registered* nurses. The intent of this paragraph is to allow them to set additional qualifications and training requirements for *school* nurses, not inconsistent with the SBE minimum standards and other applicable law. We believe this is adequately captured by the first clause of that sentence, so I have deleted the language quoted above.

Please confirm that you have consulted in accordance with G.S. 115C-270.5(b).

Consultation with PEPSC is not required for this rule because school nurses are not licensed by the State Board of Education. Consultation with PEPSC is only required for licensure rules adopted pursuant to Chapter 115C, Article 17E. This rule is adopted pursuant to G.S. 115C-315(d2).
