SUBJECT: Readoption Schedule: 21 NCAC 69

The following is submitted as required to Mr. Travis Wiggs for rules under the North Carolina Board of Licensed Soil Scientists (NCBLSS), whose periodic review reports were approved by the Rules Review Commission at the November 26, 2024, meeting.

This timeline is a proposed readoption schedule for the above-mentioned rules. The dates noted on the timeline refer to a deadline, and not a specific date, at the meeting dates for the NCBLSS for 2026 and 2027 have not yet been established. The timeline is based on previous meeting dates typical of the NCBLSS's schedule.

Presentation of rules at NCBLSS:	October 2025
Publication of Notice of Text:	October 2025 (immediately following initial approval by Board)
Public Hearing:	At least 15 but no later than 60 days after notice of text is published, if requested.
Public Comment Period:	July 26-September 24, 2024
NCBLSS meetings for final adoption:	October 2025 (March 2026, in the event that the October meeting is cancelled)
Submission of Rules to OAH for RRC Consideration:	October – March 2026
Rules Review Commission Review:	No later than June 2027
Earliest Effective Date of Rules:	July 1, 2027

Please create a timeline working with a deadline of July 1, 2027. Your timeline should be an itemized breakdown of when your agency intends to complete each step in the readoption process. This is essentially following the procedures for adopting a permanent rule in 150B-21.2. The timelines can be projections of when certain actions will be taken by your Board. Please be as specific as possible with dates, but I realize circumstances may change and unforeseeable events may arise. Please communicate to me any unexpected changes when they occur.

All rules your agency designated as “Necessary” will need to be readopted during this process. I have attached an example of a proposed readoption timeline that was submitted by a different agency with a deadline of October 1, 2027.

Pursuant to G.S. 150B-21.3A and 26 NCAC 05 .0212, the RRC sets this deadline after consultation with the agency, and this email serves as the RRC’s request for that consultation. Please review 26 NCAC 05 .0212 for the information required to be submitted to the RRC, and the deadlines for doing so.

The deadline for your agency to provide this information is April 18, 2025. As a starting point, I would recommend a July 1, 2027, readoption deadline, but I am open to considering a different recommendation based on the needs of your agency.
