<u>**18** NCAC 07C .0802:</u> Why is this rule necessary? It appears that G.S. 10B-37(b)(4) would already let the phrase "State of North Carolina" satisfy the requirement.

In order to provide a comprehensive response, we have combined our response to RFC #2 and #3 below RFC #3.

<u>RFC #3</u>

18 NCAC 07C .0802 SEAL IMAGE

A notary public's seal shall be deemed by the Department to comply with G.S. 10B-37 if it contains the words "State of North Carolina" in lieu of the designations in G.S. 10B-37(b)(4).

18 NCAC 07C .0803 SEAL LIMITATION

<u>A notary public's seal manufactured after the effective date of this Rule shall include no information or images other than those required or permitted by G.S. 10B-37 and Rule .0802 of this Section.</u>

<u>18 NCAC 07C .0803:</u> It appears that the effect of this rule in combination with .0802 limiting the seal to the specific requirements of 10B-37 or the additional "State of" language in "State of North Carolina." If that's correct, I think it would make more sense to combine .0802 and .0803 into one rule.

Consider: "A notary public's seal manufactured after the effective date of this Rule shall include no information or images other than those required by G.S. 10B-37 or the phrase "State of North Carolina.""

The Department's practical experience indicates the delineation is needed. It is not clear that "[t]he words 'North Carolina' or the abbreviation 'N.C.' or 'NC"¹ include "State of North Carolina". Rules .0802 and .0803 are intended, when read in combination with G.S. § 10B-37(b), to make clear that there is a single limited exception to the provisions of G.S. § 10B-37(b): use of the phrase "State of North Carolina".

Uniformity of the contents of notary seals is important for several reasons the most important of which is to enable a member of the public or the Bar to know at a glance that a seal is lawful in this State. We have separated the provisions of Rules .0802 and .0803 to ensure that it is clear that while "State of North Carolina" may be used, there are no other exceptions. Notaries may not, for example, include the great seal of the State of North Carolina or a geographic outline of the state's shape. Ensuring limited contents improves legibility and readability of the seal, enabling quicker determination of its legitimacy.

We carefully reviewed your proposed language and understand why you requested that we consider it. However, we feel that the proposed language would add ambiguity as we are not requiring use of the phrase "State of North Carolina". Thus, we do not propose making the proposed change.
