Good afternoon,

Per my discussion with the RRC chair, this will be on the agenda at the RRC meeting at 10:00 AM on March 27th. The meeting will be a hybrid of in-person and online. If anyone from your agency needs a webex invitation, please let me know.

Additionally, I anticipate recommending that the RRC grant the exemption requested for 18 NCAC 07J. Pursuant to 150B-21.3A (d)(1), the RRC may exempt rules from review when they have been adopted or amended in the past 10 years. The secretary of state has adopted and filed rules which significantly amend or replace all of the current rules in subchapter 07J, which will be on the RRC's agenda in April. It is my opinion that the review of the newly filed rules will satisfy the purposes of periodic review, so it would be appropriate to exempt this subchapter.
